The arbitrator's award shall be final and binding and enforceable in accordance with the Act. The parties agree to allow appeals to a court against the arbitrator's award as permitted by the Act. To the fullest extent permitted by applicable law, no arbitration under this Agreement shall be joined to an arbitration involving any other party, whether through class action proceedings or otherwise. You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of, related to or connected with the use of the Site or this Agreement must be filed within one (1) year after such claim or cause of action arose or be forever banned.
